**DEED OF TRUST & ASSIGNMENT OF RENTS**

THIS DEED OF TRUST, Made this 14th day of November, 1983 between

herein called TRUSTOR, NEBACO, Inc., a Nevada corporation, herein called TRUSTEE, and NEVADA NATIONAL BANK \_\_\_\_\_, a National banking association, organized and existing under and by virtue of the laws of the State of Nevada, herein called BENEFICIARY. (It is distinctly understood that the word "Trustor" and the words "he", "his" or "him" referring to the Trustor, as herein used, are intended to and do include the masculine, feminine and neuter genders and the singular and plural numbers as indicated by the context.)

WITNESSETH: That Trustor irrevocably grants, transfers and assigns to Trustee in Trust, with power of sale, that property in DOUGLAS County, Nevada, described as:

SEE ATTACHED EXHIBIT "A" HERETO AND MADE A PART HEREOF

TOGETHER WITH, all and singular the tenements, hereditaments, and appurtenances thereunto belonging, or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof, royalties and payments arising or accruing by reason of any oil, gas or mineral lease thereof, and installments of money payable pursuant to any agreement for sale of said property or any part thereof, SUBJECT, HOWEVER, to the right, power, and authority given to and conferred upon Beneficiary by paragraph (13) of the provisions incorporated herein by reference to collect and apply such rents, issues, profits, royalties, payments and installments of money as they become due and payable. It is specifically understood and agreed, without affecting the generality of the foregoing, that all gas, electric, heating, cooling, cooking, air-conditioning, refrigeration and plumbing appliances and equipment, which are now in or which may hereafter be attached to, or built-in in any building or improvement now or hereafter on said real property, shall be deemed fixtures and a part of the realty, and are a portion of the security for the indebtedness herein mentioned.

FOR THE PURPOSE OF SECURING: 1. Payment of the sum of \$ 42,000.00 with interest thereon, according to the terms of a promissory note or notes of even date herewith, made by Trustor, payable to the order of the Beneficiary, and extensions or renewals thereof. 2. Payment of such additional sums with interest thereon as may hereafter be borrowed from the Beneficiary by the then record owner or owners of said property when evidenced by another Promissory note or notes. 3. Payment, with interest thereon, of any other present or future indebtedness or obligation of the Trustor (or of any successor in interest of the Trustor to said property) to the Beneficiary, whether created directly or acquired by assignment, whether absolute or contingent, whether due or not, whether otherwise secured or not or whether existing at the time of execution of this Deed of Trust, or arising thereafter, when evidenced by promissory notes stating that said notes are secured hereby. 4. Performance of each agreement of Trustor herein contained.

TO PROTECT THE SECURITY OF THIS DEED OF TRUST, TRUSTOR AGREES: By the execution and delivery of this Deed of Trust and the note or notes secured hereby, that he will observe and perform all provisions; that the note and other obligations therein referred to shall be deemed to mean the obligations secured by this Deed of Trust; that the property herein referred to shall be deemed to mean the property affected by this Deed of Trust; that the terms "Trustor", "Beneficiary", and "Trustee", as used therein shall be deemed to mean the Trustor, Beneficiary, and Trustee, respectively, under this Deed of Trust; and Trustor acknowledges that he has read the copy of said provision (1) to (17), inclusive, set forth on the reverse and understands the same.

## TO PROTECT THE SECURITY OF THIS DEED OF TRUST, TRUSTOR AGREES:

(1) To keep said property in good condition and repair, not to remove or demolish any building thereon, to complete or restore promptly and in good and workmanlike manner any building which may be constructed, damaged or destroyed thereon and to pay when due all claims for labor performed and materials furnished thereon, and if the loan secured hereby or any part thereof is being obtained for the purpose of construction of improvements on said property, Trustor also agrees, anything in the Deed to the contrary notwithstanding (a) to complete same in accordance with plans and specifications satisfactory to Beneficiary; (b) to allow Beneficiary to inspect said property at all times during construction; (c) to replace any work or materials unsatisfactory to Beneficiary, within fifteen (15) calendar days after written notice from Beneficiary of such fact, which notice may be given to the Trustee by certified mail, sent to his last known address, or by personal service of the same; (d) that work shall not cease on the construction of such improvements for any reason whatsoever for a period of fifteen calendar days, to comply with all laws affecting said property or requiring any alterations or improvements to be made thereon, not to commit or permit waste thereof, not to commit, suffer or permit any act upon said property in violation of law; to cultivate, irrigate, fertilize, fumigate, prune and do all other acts which from the character or use of said property may be reasonably necessary; the specific enumeration herein not excluding the general. The Trustee, upon presentation to it of an affidavit signed by Beneficiary, setting forth facts showing a default by Trustor under this paragraph, is authorized to accept as true and conclude all facts and statements herein, and to act thereon hereunder.

(2) To provide and maintain in force at all times, fire and other types of insurance as may be required, each in an amount satisfactory to, and with loss payable to said Beneficiary. Said insurance policies shall be in form and content, and for such term, and in such corporations as may be satisfactory to the Beneficiary, and shall be delivered to and remain in possession of Beneficiary as further security for the faithful performance of these trusts.

At least sixty (60) days prior to the expiration of any said insurance policy, a policy or policies renewing or extending said existing insurance shall be delivered to said Beneficiary together with a receipt showing payment of the premium therefor. By executing this Deed of Trust the Trustee specifically requests the Beneficiary to obtain said insurance in the event any said insurance policy and a receipt for payment of the premium therefor be not so delivered to said Beneficiary by the Trustee, but Beneficiary shall be under no obligation to do so, and the obtaining of any such insurance and the payment of the premium therefor by Beneficiary shall not release Trustee from any obligation hereof. Neither Trustee nor Beneficiary shall be responsible for such insurance or for the collection of any insurance money, or for any insolvency of any insurer or insurance underwriter. Any and all unexpired insurance shall insure to the benefit of, and pass to the purchaser of, the property conveyed hereby at the Trustee's sale held hereunder.

The amount collected under any fire or other insurance policy may be applied by Beneficiary upon any indebtedness secured hereby and in such order as Beneficiary may determine, or at option of Beneficiary the entire amount so collected or any part thereof may be released to Trustee. Such application or release shall not cure or waive any default or notice of default hereunder or invalidate any act done pursuant to such notice.

(3) Should Trustee sell, convey, transfer, dispose of or further encumber said property, or any part thereof, or any interest therein, or agree so to do, without consent of Beneficiary being first obtained, then Beneficiary shall have the right at its option to declare all sums secured hereby forthwith due and payable. Consent to one such transaction shall not be deemed to be a waiver of the right to require such consent to future or successive transactions. If this Deed of Trust or any Note secured hereby contains any provision conferring on Beneficiary the right to demand any penalty, fee or sum of money for prepayment of any indebtedness secured hereby, Trustee agrees to pay the maximum amount of such penalty, fee or sum of money which Beneficiary would have been entitled to demand pursuant to such provision. If any of said indebtedness shall be paid prior to the due date thereof stated in said Note or this Deed, even if notwithstanding Trustee shall have defaulted in payment thereof, or in performance of any agreement hereunder, said Beneficiary, by reason thereof, shall have declared all sums secured hereby immediately due and payable.

Beneficiary may charge Trustee a reasonable fee, but not exceeding such amount as may from time to time be authorized by law, for furnishing any statement of notice relating to this Deed of Trust or the indebtedness hereby secured, including, but not limited to, notice showing the information specified in Chapter 107, Nevada Revised Statutes, 107.030 and 107.030. Beneficiary may also charge Trustee a reasonable fee for any other service rendered Trustee or on his behalf, connected with this Deed, or the loan secured hereby, including without limiting the generality of the foregoing, the delivery to an escrow holder of a request for full or partial reconveyance of this Deed, transmitting to an escrow holder money secured hereby, changing its records pertaining to this Deed and the loan secured hereby to show a new owner of said property, replacing an existing policy of fire insurance or other casualty insurance, held by Beneficiary hereunder, with another such policy. Any such charge shall be secured hereby and Trustee agrees to pay the same together with interest from the date of such charge at the rate specified in said note immediately and without demand.

(4) To appear in and defend any action or proceeding purporting to affect the security hereof or the rights or powers of Beneficiary or Trustee, and to pay all costs and expenses, including cost of evidence of title and attorney's fees in a reasonable sum, in any such action or proceeding, and in any action or proceeding whatsoever affecting the security hereof, including, but not limited to any condemnation proceeding in which Beneficiary or Trustee may appear or be named and any suit brought by Beneficiary to foreclose this Deed of Trust.

(5) To pay, at least ten (10) days before delinquency all taxes and assessments affecting said property, including assessments on appurtenant water stock; when due, all encumbrances, charges and liens, with interest on said property or any part thereof, which appear to be prior or superior hereto; all costs, fees and expenses of this Trust.

Should Trustee fail to make any payment or to do any act as herein provided, then Beneficiary or Trustee, but without obligation so to do and without notice to or demand upon Trustee and without releasing Trustee from any obligation hereof, may make or do the same in such manner and to such extent as either may deem necessary to protect the security hereof. Beneficiary or Trustee being authorized to enter upon said property for such purposes; appear in and defend any action or proceeding purporting to affect the security hereof or the rights and powers of Beneficiary or Trustee, pay, purchase, contest or compromise any encumbrance, charge or lien which in the judgment of either appears to be prior or superior hereto, and, in exercising any such powers pay necessary expenses, employ counsel and pay his reasonable fees.

(6) To pay immediately and without demand all sums so expended by Beneficiary or Trustee with interest from date of expenditure at the rate specified in said note.

(7) To insure the payment of taxes and assessments, which are now or hereafter may be a lien upon the property described at least ten (10) days before the delinquency thereof as provided for in paragraph (5) hereinabove, and to pay such premiums upon policies of insurance which may be required by the Beneficiary as provided for in paragraph (2) hereinabove, the Trustee agrees to pay the Beneficiary, in addition to any other payments required hereunder, an installment of the taxes and special assessments levied or to be levied against the hereinabove described premises and an installment of the premium or premiums that will become due and payable to renew the insurance on the premises covered hereby and required by the Beneficiary, Trustee agreeing to deliver promptly to Beneficiary all bills and notices thereof. Such installments shall be equal to the estimated premium or premiums for such insurance and taxes and assessments next due (as estimated by Beneficiary) less all installments already paid therefor, divided by the number of months that are to elapse before one month prior to the date such premium or premiums and taxes and assessments will become delinquent. If the amounts paid to the Beneficiary under the provisions of this paragraph are insufficient to discharge the obligation of the Trustee to pay such premium or premiums, taxes and assessments at the same become due, Trustee shall pay to Beneficiary upon its demand such additional sums as it may require to discharge Trustee's obligation to pay premium or premiums, taxes and assessments. At the option of the Beneficiary, all monies paid to Beneficiary under the terms of this paragraph shall be held by Beneficiary in trust to pay such premium or premiums, taxes and assessments before the same become delinquent, or may be credited directly to interest and principal due under the terms of the note secured hereby and upon payment by the Beneficiary of taxes, assessments and insurance premiums, the amount so paid shall be charged to the principal due upon the note secured hereby. If the Trustee shall fail to make the installments provided for in this paragraph, such failure shall constitute a default under this Deed of Trust.

(8) In the event of default in the payment of any of the amounts to be paid under the terms of the Note secured hereby or this Deed of Trust or in the performance of any of the covenants and obligations of this Deed of Trust then any funds in the possession of the Beneficiary under the provisions of paragraph (7) may at the option of the Beneficiary be applied to the payment of principal and/or interest upon the obligation secured hereby in lieu of being applied to any of the purposes for which the fund established under paragraph (7) was established.

(9) Any award of damages in connection with any condemnation for public use or of injury to said property or any part thereof is hereby waived and shall be paid to Beneficiary who may apply or release such damages received by him in the same manner and with the same effect as above provided for disposition of proceeds of fire or other insurance.

(10) By accepting payment of any sum secured hereby after its due date, Beneficiary does not waive its right either to require prompt payment when due or of all other sums to be due or to declare default for failure to so pay.

(11) At any time or from time to time, without liability thereto and without notice, upon written request of Beneficiary and presentation of this Deed and Note for enforcement, and without affecting the personal liability of any person for payment of the indebtedness secured hereby, Trustee may, recover any part of said property, consents to the making of any map or plat thereof, just as granting any easement or right of way extension agreement or any agreement subordinating the lien or charge hereof.

(12) Upon written request of Beneficiary stating that all sums secured hereby have been paid, and upon surrender of the original of this Deed and said Note to Trustee for cancellation and return and upon payment of its fees, Trustee shall retitle, without warranty, the property then held hereunder. The recitals in such reconveyance of any matters or facts shall be conclusive proof of the truthfulness thereof. The grantee in such reconveyance may be described as "the person or persons legally entitled thereto." One year after issuance of such full reconveyance, Trustee may destroy said Note and this Deed (unless directed in such request to retain them). Such request and reconveyance shall operate as a reconveyance of the rents, issues, profits, rents and profits hereinafter assigned to Beneficiary.

(13) As additional security, Trustee further gives to and secures upon the hereinabove the right, power, and authority, during the continuance of this trust, to collect the rents, issues, profits, royalties and payments of oil and gas, of mineral lease thereof, and all installments of money payable pursuant to any agreement for the sale of said property or any part thereof, reserving unto Trustee the right prior to default by Trustee in payment of any indebtedness secured hereby, or in performance of any agreement hereunder, to collect and retain such rents, issues, profits, royalties, payments and installments of money, as they become due and payable. Upon any such default, Beneficiary may at any time without notice, either in person, by agent, or by a receiver to be appointed by a court, and without regard to the adequacy of any security for the indebtedness hereby secured, seize and take possession of said property or any part thereof, as the case may be, for or otherwise collect such rents, issues, profits, royalties, payments and installments of money, including those past due and unpaid, and apply the same, less costs and expenses of operation and collection, including reasonable attorney's fees upon any indebtedness secured hereby, and in such order as Beneficiary may determine. If Beneficiary should take possession of said property, Beneficiary may tent or lease any or all of said property upon such terms as may be reasonable under all the circumstances. The entry upon and taking possession of said property, the collection of such rents, issues, profits, royalties, payments and installments of money, and the application thereof as aforesaid, shall not cure nor waive any default or notice of default hereunder nor invalidate any act done pursuant to such notice. Failure or discontinuance of Beneficiary at any time or from time to time to collect any such money shall not in any manner impair the subsequent rights of Beneficiary of the right, power and authority herein conferred upon it. Nothing contained herein, nor the exercise of any right, power or authority herein granted to Beneficiary, shall be or be construed to be an affirmation by it of any tenancy, lease or option, nor as an assumption of liability under, nor a subordination of the lien or charge that shall be, and each tenancy lease or option.

(14) If breach or default be made in the prompt payment, when due, of any sum secured hereby, or in the performance of any promise contained herein, or contained in any conveyance made which said Trustee claims or derives title to and at any time thereafter the Beneficiary, hereunder may declare all sums secured hereby immediately due and payable, without demand or notice, and the Beneficiary or Trustee shall record in the office of the County Recorder of the county in which said property or any part thereof is situated, a notice of such breach or default and election to cause the said property to be sold to satisfy the indebtedness and obligation secured hereby, as provided by the laws of the State of Nevada with reference to the foreclosure of deeds of trust.

On application of the Beneficiary, and after at least three (3) months shall have elapsed following the recording of said notice of breach or default, the Trustee shall give notice of the time and place of sale in the manner and for a time not less than that required by law for the sale or sales of real property under execution, and without deposit on separate parcels, and in such order as it may determine, at public auction to the highest bidder for cash in lawful money of the United States, payable at time of sale. Trustee may propose sale of all or any portion of said property by public auction at such time and place of sale, and from time to time thereafter may postpone such sale by public auction at the time fixed by the preceding postponement, and without further notice it may make such sale at the time to which the same shall be postponed. Trustee shall deliver to the purchaser the deed conveying the property so sold, but without any warranty of title, express or implied. The rental in the such deed of any interest or term stated therein specifically or in general terms, or as conditions of law or fact, shall be conclusive proof of the truthfulness thereof, and such deed shall not contain against all persons as to conditions or facts therein recorded. Any person, including Trustee, Trustee or Beneficiary, may purchase at such sale. Trustee hereby agrees to execute immediately, and without demand, power of sale property (realty purchased at any sale held hereunder). In the conduct of any such sale the Trustee may act itself, or through any attorney, agent or otherwise. In addition to the indebtedness and other obligations secured hereby, the Trustee freely agrees to pay the expenses of such sale and of this trust, and compensation of the Trustee in an amount equal to one per cent (1-1/2%) of the amount necessary unpaid and unpaid hereby, but in no event less than Twenty-five Dollars (\$25.00), and causing fees to an amount equal to one per cent (1-1/2%) of the amount necessary unpaid and unpaid hereby, but in no event less than One Hundred Dollars (\$100.00), and also such costs, if any, as Trustee or Beneficiary shall have paid for preparing an abstract of title or search of or certificate or report as to the title to and premises of any part thereof subsequent to the recording of this instrument, all of which items shall be secured hereby and become due upon any default hereunder made by the Trustee. The Trustee shall apply the proceeds of any sale held hereunder to the satisfaction of the unsecured hereby and before the open and default hereunder made by the Trustee. The Trustee shall apply the proceeds of any sale held hereunder to the satisfaction of the sums secured hereby, in such order and to such extent as the Beneficiary, in the exercise of its absolute discretion, may direct. Any surplus in the hands of the Trustee after the payment of all sums secured hereby shall be paid to the person or persons legally entitled thereto on the part of such right. Trustee agrees to pay forthwith to Beneficiary or other person or persons entitled thereto any deficiency remaining after the application of the proceeds of sale to the payment of all sums secured hereby.

(15) Beneficiary may, from time to time, by instrument in writing, whether a successor or successor to any Trustee named herein or acting hereunder, which instrument executed and acknowledged by Beneficiary and recorded to the office of the recorder of the county or counties where and property is situated, shall be conclusive proof of proper substitution of such successor Trustee, who shall without notice leave from the Trustee predecessor, succeed to all title, estate, rights, powers and duties, and instruments and assume the name of the original Trustee. Trustee and Beneficiary hereunder, the bank and page where this Deed is recorded, and the names and addresses of the new Trustee, if notice of death shall have been received, this power of substitution cannot be exercised until all the costs and expenses of the Bank acting Trustee shall have been paid to such Trustee, who shall induce receipt thereof upon such a instrument of substitution. The procedure herein provided for substitution of Trustee shall be exclusive of all other provision for substitution, statutory or otherwise.

(16) This Deed applies in whole to the Trustee and, and binds all parties herein, their heirs, legatees, devisees, administrators, executors, successors and assigns. The term "Beneficiary" shall mean the owner and holder, including grantees of the Note secured hereby, whether or not named as Beneficiary herein in the Deed, whenever the context so requires. The word "owner" includes the trustee and co-trustee and the trustee and co-trustee under the Deed.

(17) Trustee excepts that from when this Deed, date executed and acknowledged, it made a public record as provided by law, Trustee is not obligated to notify any party holder of pending sale under any other Deed of Trust or of any action or proceeding in which Trustee, Beneficiary or Trustee shall be a party unless brought by Trustee.

Do not lose or destroy this Deed of Trust OR THE NOTE which it secures.

Both must be delivered to the Trustee for cancellation before reconveyance will be made.

**DESCRIPTION**

Situate in the County of Douglas, State of Nevada, described as follows:

Commencing at the iron bar which marks the Northern corner of Lot 8 in Block D as shown on the Amended Map of Zephyr Cove Properties in Section 10, Township 13 North, Range 18 East, M.D.B.&M., filed in the office of the County Recorder of Douglas County, Nevada, on August 5, 1929; thence South  $53^{\circ}45'$  East a distance of 25.00 feet to a point; thence South  $57^{\circ}45'$  East a distance of 15.21 feet to the true point of beginning; thence South  $57^{\circ}45'$  East a distance of 101.36 feet to a point on the Western right-of-way line of U.S. Highway 50; thence South  $42^{\circ}54'$  West along said Western right-of-way line a distance of 68.36 feet to a point marked by a nail; thence North  $65^{\circ}59'$  West a distance of 47.64 feet to a point marked by an iron post which bears South  $12^{\circ}22'$  East a distance of 114.10 feet from the point of commencement; thence North  $3^{\circ}08'$  East a distance of 87.48 feet to the true point of beginning.
