As to all other property described in said Deed of Trust, the said Deed of Trust remains in full force and effect.

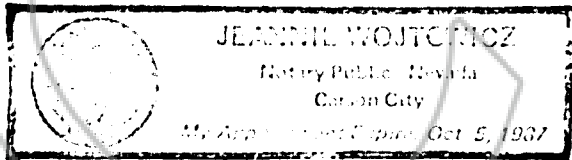
