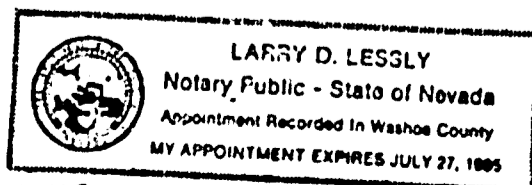


EXHIBIT "A"

Phase 1 Boundary

Beginning at the most Westerly point of the boundary of said Valley Villa Subdivision;

thence along the Northerly line of said Valley Villa Subdivision the following 8 courses:

- 2) from a tangent which bears South $41^{\circ}50'00''$ East along a circular curve to the left with a radius of 500.00 feet and a central angle of $04^{\circ}04'28''$, an arc length of 35.56 feet;
- 3) North $44^{\circ}05'32''$ East, a distance of 50.00 feet;
- 4) North $34^{\circ}09'31''$ East, a distance of 85.00 feet;
- 5) North $39^{\circ}20'37''$ west, a distance of 40.00 feet;
- 6) North $29^{\circ}39'45''$ East, a distance of 126.95 feet;
- 7) South $42^{\circ}08'03''$ East, a distance of 104.89 feet;
- 8) from a tangent which bears South $45^{\circ}05'24''$ East along a circular curve to the left with a radius of 465.00 feet and a central angle of $28^{\circ}39'01''$, an arc length of 232.52 feet;

thence South $16^{\circ}15'35''$ West, a distance of 44.24 feet;
thence South $40^{\circ}38'48''$ West, a distance of 68.34 feet;
thence South $12^{\circ}51'24''$ West, a distance of 61.31 feet;
thence South $22^{\circ}00'49''$ West, a distance of 60.15 feet to the Northeast corner of Lot 17 of Block C of said Valley Villa Subdivision;
thence South $02^{\circ}11'11''$ East, along the Easterly line of said Lot 17, a distance of 30.00 feet to the Southeast corner of said Lot 17;
thence South $60^{\circ}19'32''$ West, a distance of 329.53 feet to a point on the Westerly line of said Valley Villa Subdivision;
thence North $29^{\circ}40'28''$ West, along the Westerly line of said Valley Villa Subdivision, a distance of 385.30 feet to the point of beginning.
