JUDGMENT OF PATERNITY
AND ORDER FOR SUPPORT AND
REIMBURSEMENT OF PUBLIC
ASSISTANCE

15 The above entitled case came on regularly for hearing on
16 February 16, 1984, in the above entitled Court. Plaintiffs
17 appeared by and through their counsel, the El Dorado County Dis-
18 trict Attorney. Defendant was not personally present in Court
19 when the following was audibly pronounced:

20 Upon proof being made to the satisfaction of the Court,
21 THE COURT FINDS that the defendant was personally served
22 with process and has not appeared or answered the Complaint, or
23 taken any other proceedings within the time provided by law, and
24 that the default of the defendant has been duly and regularly en-
25 tered and a Declaration on Non-Military Status has been filed as
26 provided by law.

27 The Court having considered the evidence, and it appearing
28 to the Court that all of the allegations contained in the Complaint

1 are true;

2 IT IS ORDERED ADJUDGED AND DECREED:

3 1. That all of the allegations set forth in the Complaint
4 are true and correct.

5 2. That defendant is the natural father and Patricia Church
6 is the mother of Dorey Ann Levi, born January 20, 1975.

7 3. That defendant pay for the support of his minor child,
8 the sum of \$253.00 per month, commencing December 1, 1983, and to
9 continue paying said amount on the first day of each and every
10 month thereafter until further order of the Court.

11 4. That the defendant pay forthwith the sum of \$7,696.00 as
12 and for reimbursement to the County of El Dorado for public assis-
13 tance provided for Dorey Ann Levi from May, 1981, through November,
14 1983.

15 5. That defendant shall make said payments for child support
16 payable to Patricia Church, and reimbursement payable to the
17 COUNTY OF EL DORADO, and send both to the Office of the District
18 Attorney, Family Support Department, at 515 Main Street, Placer-
19 ville, California 95667.

20 6. That defendant provide reasonable medical insurance
21 coverage for the minor plaintiff and to provide the Office of the
22 District Attorney, Family Support Department with evidence of such
23 coverage.

24 7. That if defendant becomes unemployed, the County will
25 intercept a portion of his unemployment benefit insurance as
26 provided by law.

27 8. That if defendant becomes in arrears more than thirty
28 (30) days, that a wage assignment be ordered as provided by law.

1 9. That the above judgment does not prohibit the County
2 from putting defendant in State and Federal tax intercept program.

3 10. That defendant shall advise the District Attorney,
4 Family Support Department, in writing, within ten days of every
5 change of address or employment. Said advisement shall consist of
6 the name and address of each new employer and each new residence.

7 11. That the District Attorney is ordered to enforce all
8 child support orders arising out of this action.

9 12. That defendant pay the sum of \$150.00 as and for
10 attorney's fees incurred in prosecuting this action, said sum to
11 be paid forthwith to the El Dorado County Office of the District
12 Attorney, Family Support Department, at 515 Main Street, Placer-
13 ville, California 95667.
