WILLIAM DeBRUIN and LORI DeBRUIN

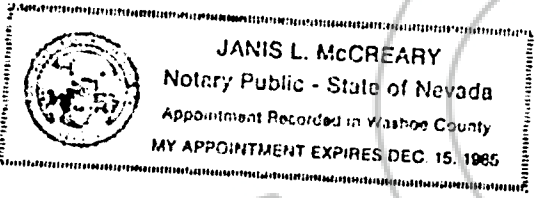
