Excerpts From Internal Revenue Code

Sec. 6321. Lien For Taxes.

If any person liable to pay any tax neglects or refuses to pay the same after demand, the amount including any interest, additional amount, addition to tax, or assessable penalty, together with any costs that may accrue in addition theretol shall be a lien in favor of the United States upon all property and rights to property, whether real or personal, belonging to such person.

Sec. 6322. Period Of Lien.

Unless enother date is specifically fixed by law, the lien imposed by section 6321 shall arise at the time the assessment is made and shall continue until the liability for the amount so assessed for a judgment against the taxpayer arising out of such liability) is satisfied or becomes unenforceable by reason of lapse of time

Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security Interests, Mechanic's Lienors, And Judgment Lien Creditors. —

The lien imposed by section 6321 shall not be valid as against any purchaser, holder of a security interest, mechanic's lienor, or judgment lien creditor ural notice thereof which meets the requirements of subsection III has been filed by the Secretary.

(b) Protection For Certain Interests Even Though Notice Filed. — Even though notice of a lien imposed by section 6321 has been filed, such lien shall not be valid -

(i) Real Property. In the case of real property, in one office within the State for the county, or other governmental subdivision), as designated by the laws of such State, in

In the case of personal property, whether tangible or intangible, in one office within the State for the county, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the lien is situated;

(B) With Clerk Of District Court. In the office of the clerk of the United States district court for the judicial district in which the property subject to lien is situated, whenever the State has not by law designated one office which meets the requirements

of subparagraph (A), or ICI With Recorder Of Deeds Of The District Of Columbia. - In the office of the Recorder of Deeds of the District of Columbia, if the property subject to the lien is situated in the District of

121 Situs Of Property Subject To Lien. For purposes of paragraphs (1) and (4), property shall be deemed to be situated (A) Real Property. In the case of real property, at its physical location; or

(B) Personal Property. In the case of personal property, whether tangible or intangible, at the residence of the taxpayer at the time the notice of lien is filed.

For purposes of paragraph (2) (B), the residence of a corporation or partnership shall be deemed to be the place at which the principal executive office of the business is located, and the residence of a taxpayer whose residence is without the United States shall be deemed to be in the District of Columbia.

111 General Rule. - Unless notice of tien is refiled in the manner prescribed in paragraph 121 during the required refiling period, such notice of lien shall be treated as filed on the date on which it is filed fin accordance with subsection III I after the expiration of such refiling period.

12) Place For Filling. - A notice of lien refiled during the required refiling period shall be effective only (A) if

(i) such notice of lien is refiled in the office in which the prior notice of lien was filed, and

firm the case of real property, the fact of refiling is entered and recorded in an index to the extent required by subsection (f) (4); and

(B) in any case in which, 90 days or more prior to the date of a refuling of notice of lien under subparagraph (A), the Secretary received written information (in the manner prescribed in regulations issued by the Secretaryi concerning a change in the taxpayer's residence, if a notice of such lien is also filed in accordance with subsection (f) in the State in which such residence is located.

(3) Required Refiling Period. — In the case of any notice of lien, the term "required refiling period" means (A) the one-year period ending 30 days after the expiration of 6 years after the date of the assessment of the tax, and (B) the one year period ending with the expiration of 6 years after the close of the preceding required refiling period for such notice of lien.
