The total amount of the lien, including interest to date is the sum of \$ 649.10, together with interest therein from date at the rate of nine percent (9%) per annum. The amount of the lien represents delinquent monthly homeowners' dues for the months of March (Bal due of \$5.00) April, May, June, July.
