

COLLATERAL ASSIGNMENT OF DEED OF TRUST

TOGETHER with any modifications, amendments and supplements to or extensions of the Buyer Deed of Trust or the Buyer Note;

FOR THE PURPOSE OF FURTHER SECURING the payment of the indebtedness evidenced by certain promissory notes from Assignor to Assignee (the "Notes") executed pursuant to that certain credit Agreement dated June 18, 1984.

ASSIGNOR HEREBY COVENANTS AND AGREES that a default under any of the terms, conditions or provisions of the Notes, the Credit Agreement dated June 18, 1984 or the Guaranty Agreement dated June 18, 1984, shall permit Assignee to enforce the Buyer Deed of Trust and the Buyer Note, and to take such action to obtain title to and possession of the Buyer Deed of Trust and the Buyer Note as is authorized by Nevada law.

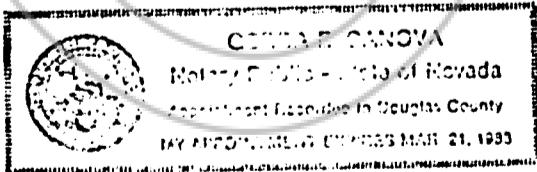
