THIS INDENTURE WITNESSETH: THAT TAHOE SUMMIT CORPORATION, a Nevada Corporation

THE FIRST PART IN CONSIDERATION OF \$10.00. THE RECEIPT OF WHICH IS HEREBY ACKNOWLEDGED. DO HEREBY. GRANT, BARGAIN, AND SELL TO Joseph Sidran and Alberta D. Sidran, Husband and Wife, as Joint Tenants

THE SECOND PART AND TO THEIR HEIRS AND ASSIGNS. ALL THAT REAL PROPERTY SITUATE IN County of Douglas, State of Nevada PARTICULARLY DESCRIBED AS FOLLOWS

PARCEL 1: An undivided 1/51st interest in and to that certain condominium described as follows: (i) An undivided 1/9th interest, as tenants-in-common, in and to Lot 28 of Tahoe Village Unit No. 2, Third Amended Map, recorded February 26, 1981, as Document No. 53845, Official Records of Douglas County, State of Nevada, except therefrom Units 1 to 9; (ii) Unit No. F, as shown and defined on said last mentioned map. 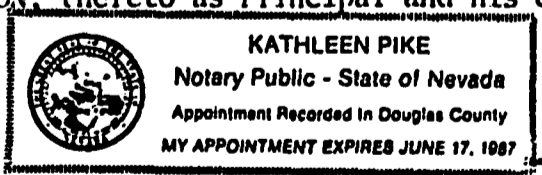
