

Certificate of Location of Lode Mining Claim

The claim is 1500 feet long and 600 feet wide, and 750 feet is claimed in a NORTH E. direction and 750 feet in a SOUTH W. direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the NORTH to the SOUTH.
