

NOTICE OF CLAIM OF LIEN

3 NOTICE IS HEREBY GIVEN that between August 9, 1984, and  
4 August 23, 1984, MEEKS BUILDING CENTER OF CARSON CITY, the claim-  
5 ant herein, furnished building materials to P-K CONSTRUCTION, for  
6 use in the construction, alteration or repair of a building or  
7 structure in Douglas County, Nevada, all of which was so actually  
8 used, and all of which was of the reasonable value of FIVE THOUSAND  
9 TWO HUNDRED SEVENTEEN & 78/100 DOLLARS (\$5,217.78); after deducting  
10 all just credits and offsets there is now owing and unpaid to MEEKS  
11 BUILDING CENTER OF CARSON CITY, claimant herein, from the said P-K  
12 CONSTRUCTION the full sum of FIVE THOUSAND TWO HUNDRED SEVENTEEN  
13 & 78/100 DOLLARS (\$5,217.78), and that the claimant has demanded  
14 and does now demand the payment thereof; that all of said material  
15 was sold and payment was due on the day of delivery, that said  
16 materials consisted of miscellaneous building materials.

23 have elapsed since the completion of work or improvement.

25 pursuant to the provisions and laws of the State of Nevada relating  
26 to liens of mechanics and others, claims a lien upon the above-  
27 described premises, together with the buildings and improvements  
28 thereon situate, for said materials furnished to the said P-K  
29 CONSTRUCTION in the amount of FIVE THOUSAND TWO HUNDRED SEVENTEEN  
30 & 78/100 DOLLARS (\$5,217.78) and for the costs of preparing,  
31 filing and service of this lien.
