17 WESSELS, having been personally served with Summons, and having  
18 failed to appear and answer or otherwise defend the Plaintiff's  
19 Complaint, and the legal time for answering having expired  
20 and no answer or other responsive pleading having been filed,  
21 the default of the Defendant, in the premises, having been  
22 duly entered according to law, and upon the Motion of the  
23 Plaintiff, judgment is hereby rendered in favor of Plaintiff  
24 and against Defendant pursuant to the Plaintiff's Complaint.

25 NOW, THEREFORE, by virtue of the law and by reason  
26 of the premises aforesaid, it is hereby

27 ORDERED, that Plaintiff, NEVADA BANKING COMPANY,  
28 have and recover from Defendant, GUNTHER WESSELS, the principal  
29 sum of EIGHTY-SEVEN THOUSAND FOUR HUNDRED FORTY DOLLARS SIXTY-  
30 FIVE CENTS. (\$87,440.65), with interest at the contract rate  
31 of FORTY-ONE DOLLARS THREE CENTS (\$41.03) per day, each and  
32 every day from July 17, 1984, in the sum of FOUR THOUSAND
