QUITCLAIM DEED

THIS INDENTURE, made and entered into on the date set forth below, by and between JOHN C. HENNINGSEN and VIRGINIA S. HENNINGSEN, of the County of Douglas, Nevada, Grantors, and the same JOHN C. WITNESSETH:

That the Grantors, without consideration other than in their own best interests and in connection with planning of their estate, do hereby quitclaim unto the Grantees as Trustees of the JOHN C. AND VIRGINIA S. HENNINGSEN NEVADA TRUST, and to their successor trustees and assigns forever, as the community property of the Grantors, all of their right, title and interest in and to that certain lot, piece or parcel of real property located in the County of Douglas, State of Nevada, and more particularly described as follows, to-wit:

The southwest one-quarter (SW¼) of Section 5, and the West one-half of the Southeast one-quarter (SE¼) of Section 5, Township 12 North, Range 20 East, M.D.B.& M.

Also what is known as the Clarence W. Henningsen wood land located in the Pine Nut Range area, Douglas County, Nevada, more particularly described as the East one-half (E½) of the Northwest one-quarter (NW¼) of Section 23, Township 12 North, Range 21 East, M.D.B.& M.

TOGETHER WITH all easements and rights of way used in connection therewith or as a means of access thereto and all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD, all and singular the said premises, together with the appurtenances unto the Grantees as Trustees of said Trust, as community property of the Grantors, and to their successor trustees and assigns forever.

IN WITNESS WHEREOF, the Grantors have hereunto set their hands this 1st day of December, 1983.

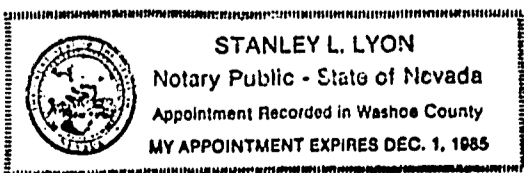
