15 Trustee under the aforesaid Deed of Trust.

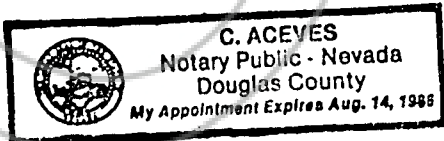
