The exclusive right to use said Unit and the non-exclusive right to use the real property referred to in subparagraph (a) of Parcel One and Parcel Two above during One "Use Period" within the SUPPLER "Seasons", as said quoted terms are defined in the Declaration of Time Share Covenants, Conditions and Restrictions, recorded October 24, 1983 as Document No. 89976 of said Official Records.

The above described exclusive and non-exclusive rights may be applied to any available unit in the project, during said Use Period within said Season.

- 1. Trustor promises and agrees to pay when due all assessments, dues and membership fees assessed by or owing to the Tahoe Summit Village Time Share Association upon the above described premises and shall not permit said claims to become a lien upon the premises; to comply with all laws respecting to said property and not to commit or permit any acts upon said property in violation of a law, covenant, condition or restrictions affecting said property.
- 2. Trustor promises and agrees that if Trustor becomes insolvent or makes a general assignment for the benefit of creditors; or if a petition in bankruptcy is filed by or against the Trustor; or if a proceeding be voluntarily or involuntarily instituted for reorganization or other debtor relief provided for by the Bankruptcy Code; or except as provided in paragraph 3 below, if Trustor shall sell, transfer, hypothecate, exchange or otherwise agree to sell by contract of sale are otherwise be divested of title in any manner or way, whether voluntarily or involuntarily, or by operation of law or otherwise; then upon the happening of any such events, the Beneficiary, at its option, may declare all promissory notes, sums and obligations secured hereby immediately due and payable without demand or notice, irrespective of the maturity dates expressed therein, and Beneficiary or Trustee may record a notice of such breach or default and elect to cause said property to be sold to satisfy the indebtedness and obligation secured hereby.
- 3. This deed of trust may be assumed only when the following conditions have been met: The payment to Beneficiary or assigns of an assumption fee of \$150.00 per interval week; credit approval of the new purchaser by the Beneficiary; completion by the new purchaser of an acceptance form and a statement of acknowledgement of all time share documents.
- 4. Beneficiary hereby agrees, and in the event of default under the terms of this deed of trust and upon return to Beneficiary of the property secured hereby, that the liability of Trustor shall be limited to all monies paid to date of the return of said property and that no deficiency judgment shall lie against the Trustor.
