12 CHARLOTTE L. GODECKE, Executrix of the Will of WILLIAM G.  
13 GODECKE, deceased, having filed the petition for its settlement  
14 and for final distribution coming on this 26th day of August,  
15 1985, regularly for hearing, in Department Two for the Ninth  
16 Judicial District in and for the County of Douglas, State of  
17 Nevada, the Honorable Norman C. Robison presiding, the court  
18 finds:

19 Notice of the hearing of the petition has been regularly  
20 given as prescribed by law.

21 All allegations of the petition are true.

22 That WILLIAM G. GODECKE died testate on the 17th day of  
23 October, 1984, in the town of Reno, County of Washoe, State of  
24 Nevada and at the time of his death he was a resident of the town  
25 of Minden, County of Douglas, State of Nevada.

26 Decedents Will dated December 27, 1978 was admitted to  
27 probate by order of this court dated January 8, 1985. Petitioner  
28 qualified as Executrix on January 8, 1985 and Letters  
29 Testamentary were issued on that date and she has at all times  
30 since then and now is the Executrix of the decedents Will.

31 Petitioner has performed all the duties required of her as

1 Executrix of the decedents Will and with respect to the  
2 administration of the estate and the estate is ready for  
3 distribution and is in a condition to be closed.

4 Notice to creditors has been duly given, published, and  
5 filed, together with an affidavit showing its due publication.

6 No claims have been filed or presented against the estate  
7 and all debts of the decedent and of the estate and all expenses  
8 of administration have been paid except for the payment to said  
9 Petitioner's attorney his agreed fee of \$600.

10 An inventory and appraisalment of the estate was returned and  
11 filed on January 22, 1985 showing the value of the estate to be  
12 29,464.29. Petitioner alleges that such inventory contains all  
13 the assets of the decedents estate that have come to Petitioners  
14 knowledge or into her possession that are within the State of  
15 Nevada.

16 The whole of the decedents estate in this proceeding  
17 consists of an undivided 33/112 ownership in the following  
18 described real property situate within Douglas County, Nevada:

20 All that certain lot, piece or parcel of land  
21 situate in the County of Douglas, State of  
22 Nevada, described as follows:

23 BEGINNING at the Southwest corner of the  
24 parcel to be described hereby, being a point  
25 in the South line of the Northwest Quarter of  
26 said Section 29, and from which the South  
27 Quarter corner of Section 30, Township 13  
28 North, Range 20 East, M.D.B. & M., bears South  
29 89 54' 12" West 687.30 feet and South 44 45'  
30 27" West, 3764.09 feet; thence from the point  
31 of beginning and along the South line of said  
32 Northwest Quarter South 89 29' 26" East  
324.29 feet; thence North 9 04' 08" West  
183.92 feet; thence North 88 47' 40" West  
291.35 feet; thence South 1 14' 25" West  
184.92 feet to the POINT OF BEGINNING.

20 decedent or estate not now known or discovered in

21 the State of Nevada be made to the persons
