lands.

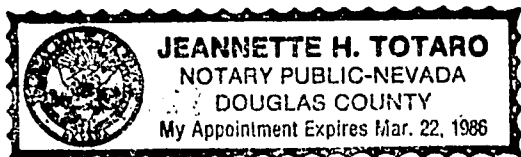
