19 Defendant, THOMAS AND SONS CONSTRUCTION, INC., a Nevada

24 has been compelled to employ counsel and incur costs herein and  
25 that Plaintiff is entitled to a reasonable attorney's fee.

26 NOW, THEREFORE, IT IS HEREBY ORDERED that Plaintiff have  
27 judgment against the Defendant in the sum of FIFTEEN THOUSAND NINE  
28 HUNDRED SIXTY-EIGHT DOLLARS and EIGHTY-SEVEN CENTS (\$15,968.87),  
together with accrued interest thereon at the rate of TEN PERCENT  
(10%) per annum from April 29, 1981, in the sum of SEVEN THOUSAND  
FIFTY-THREE DOLLARS and THIRTY-TWO CENTS (\$7,053.32), together

1 with the Plaintiff's costs of suit in the sum of TWO HUNDRED  
2 EIGHTY-SEVEN DOLLARS and SIXTY CENTS (\$287.60), together with an  
3 attorney's fee in the sum of ONE THOUSAND EIGHT HUNDRED TWENTY  
4 DOLLARS (\$1,820.00), with interest on all of said sums, except  
5 accrued interest, at the rate of TEN PERCENT (10%) per annum from  
6 the date hereof until judgment has been satisfied; and

7 IT IS FURTHER ORDERED that execution issue against the  
8 said Defendant for said sums.
