STANDARD FORM OF AGREEMENT TO ENGAGE ENGINEERING SERVICES

THIS AGREEMENT, entered into at Stateline, Nevada, on the 12th day of December, 1985, by and between Douglas County, Paul Fillebrown, Director of Public Works, P. O. Box 218 Minden, NV 89423 Telephone (702) 588-3666 hereinafter called "Client" and JERE E. WILLIAMS, CONSULTING ENGINEER, hereinafter called "Engineer", is as follows:

The client intends to obtain rights-of-way for U.S. 50 Bypass, Kingsbury Grade to Elk Point Road, hereinafter called the "Project."

The client and engineer for mutual consideration hereinafter set forth, agree as follows:

- A. Engineer agrees to perform certain planning, design and/or surveying services for the client as follows:

Provide three rights-of-way descriptions for bypass road across Rabe, Lake Village and U.S.F.S. properties as directed by Client. Work is to be accomplished by December 31, 1985.

- B. Client agrees to compensate engineer for such services as follows:

Per diem as shown on the attached hourly rate schedule, \$2000.00 maximum unless additional work is specifically authorized by client.

NOTE: Under provisions of this Agreement, a late payment FINANCE CHARGE, will be computed at the periodic rate of 1-1/2% per month, which is an ANNUAL PERCENTAGE rate of 18%, and will be applied to any unpaid balance commencing 30 days after the date of the original invoice.

- C. The Standard Agreement Provisions set forth on Appendix A and attached hereto are incorporated hereinto and made a part of this agreement.
