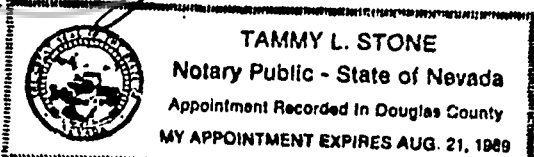

The above described exclusive and non-exclusive rights may be applied to any available unit in the project during said "use week" in said above mentioned use season.
