WHEREFORE, by virtue of the law and by reason of the premises aforesaid, IT IS ORDERED, ADJUDGED AND DECREED that the said plaintiffs have and recover from the defendant, BILL M. GREEN, individually, the sum of SEVEN HUNDRED EIGHTY-SIX THOUSAND SEVEN HUNDRED TWENTY-TWO AND 58/100 DOLLARS (\$786,722.58), with interest at the rate of TWO HUNDRED TWO AND 92/100 DOLLARS (\$202.92), from and including the 11th day of February, 1986, to the date of this judgment, and said plaintiffs have and recover from the defendants, BILL M. GREEN and RONALD GRAVES, individually and doing business as BILL GREEN CONSTRUCTION, the sum of NINE HUNDRED SIXTY-SEVEN THOUSAND SIX HUNDRED THIRTY-SIX AND 46/100 DOLLARS (\$967,636.46), with interest at the rate of TWO HUNDRED TWENTY EIGHT AND 24/100 DOLLARS (\$228.24), from and including the 11th day of February, 1986, to the date of this judgment; together with reasonable attorney's fees in the amount of \$ 3,000.00, and costs in the amount of \$ 118.00, with interest on the total judgment at the rate of twelve percent (12%) per annum from date hereof.
