## LEGAL DESCRIPTION

All that certain lot, piece or parcel of land situate in the County of Douglas, State of Nevada, described as follows:

A parcel of land, located in the Northeast 1/4 Northwest 1/2 of Section 16, Township 12 North, Range 20 East, M.D.B. & M., Douglas County, Nevada, more paticularly described as follows:

Commencing at the North quarter corner of said Section 16, proceed South 0°11'05" West, 663.50 feet, along the Westerly right-of-way line of Tillman Lane, and West 930.35 feet, to the True Point of Beginning, which is the Northwest corner of the parcel; thence South 0°11'05" West 157.66 feet, to the Southwest corner of the parcel; thence East 276.28 feet, to the Southeast corner of the parcel; thence North 0°11'05" East, 157.66 feet, to the Northeast corner of the parcel thence West 276.28 feet, to the True Point of Beginning.

Together with a non-exclusive easement, for a public road and utilities fifty feet in width, the certerline of which is described as follows:

Commencing at the Northwest corner of the above-described parcel, proceed West 25.00 feet, and South 0°11'05" West, 107.66 feet, to the True Point of Beginning, proceed thence South 0°11'05" West, 390.32 feet, and East, 955.35 feet, to the Point of Termination, which lies on the Westerly right-of-way line of Tillman Lane, and bears South 0°11'05" West, 1161.49 feet, from the North quarter corner of Section 16, Township 12 North, Range 20 East, M.D.B. & M.
