POWER OF ATTORNEY

19 rights and demands whatsoever, liquidated or unliquidated, as are
20 now, or shall hereafter become due, owing, payable, owned or

23 equitable remedies, procedures, and writs in my name for the
24 collection and recovery thereof, and to compromise, settle and
25 agree for the same, and to make, execute and deliver for me and
26 in my name all endorsements, acquittances, releases, receipts or
27 other sufficient discharges for the same;



28 effect for five years from date of making.

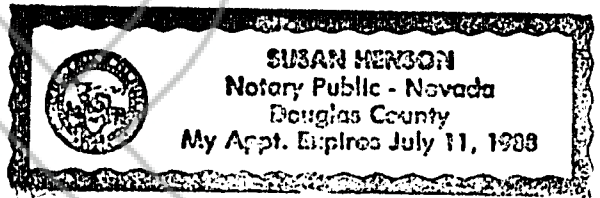
