18 of December, 1984, sitting without a jury, the Plaintiff appearing
19 through D. GERALD BING, JR., and through its counsel, JAMES M.
20 O'REILLY, ESQ., and there being no appearance by the Defendant;
21 the Court having heard the testimony and having examined the
22 proofs offered by the Plaintiff and the files herein, and the
23 Court being fully advised in the premises, now makes the following
24 judgment:


26 IT IS ORDERED, ADJUDGED AND DECREED that the Plaintiff, BING
27 CONSTRUCTION COMPANY OF NEVADA, doing business as BING MATERIALS,
28 is hereby awarded judgment against the Defendants, JAMES SHRYOCK
29 and SHRYOCK BROTHERS CONSTRUCTION, for the sum of TWENTY-SIX
30 THOUSAND FOUR HUNDRED NINETY-THREE DOLLARS and SEVENTY-TWO CENTS
31 (\$26,493.72), together with interest thereon at twelve percent
(12%) per annum from the 21st day of June, 1984, until paid in
full, together with all costs of court in the amount of \$101.00.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that judgment is

1 to be paid in the following manner, to-wit: ONE THOUSAND DOLLARS
2 (\$1,000) per month commencing on the 25th day of January, 1985,
3 and thereafter on the 25th day of each succeeding month until the
4 total judgment has been paid. All such payments shall be made in
5 a timely manner to JAMES M. O'REILLY, ESQ., TRUST ACCOUNT, 1476
6 Main Street, P. O. Box 1268, Gardnerville, Nevada 89410. So long
7 as the Defendants are timely paying such monthly installments, the
8 Plaintiff shall not otherwise levy or execute upon any property,
9 real or personal, or seek any assignment of wages or otherwise, or
10 garnish any other assets of the Defendants. However, should the
11 Defendants, or either of them, default in the making of any such
12 payments, an execution may immediately issue without further
13 notice, for the full amount due together with all interest, costs
14 and an attorney's fee to JAMES M. O'REILLY, ESQ., in the amount of
15 ONE THOUSAND DOLLARS (\$1.000).
