to be paid in the following manner, to-wit: ONE THOUSAND DOLLARS (\$1,000) per month commencing on the 25th day of January, 1985, and thereafter on the 25th day of each succeeding month until the total judgment has been paid. All such payments shall be made in a timely manner to JAMES M. O'REILLY, ESQ., TRUST ACCOUNT, 1476 Main Street, P. O. Box 1268, Gardnerville, Nevada 89410. So long as the Defendants are timely paying such monthly installments, the Plaintiff shall not otherwise levy or execute upon any property, real or personal, or seek any assignment of wages or otherwise, or garnish any other assets of the Defendants. However, should the Defendants, or either of them, default in the making of any such payments, an execution may immediately issue without further notice, for the full amount due together with all interest, costs and an attorney's fee to JAMES M. O'REILLY, ESQ., in the amount of ONE THOUSAND DOLLARS (\$1.000).
