REASSIGNMENT OF  
DEEDS OF TRUST

THIS REASSIGNMENT is made this 26th day of June, 1986, by and between THE FEDERAL RESERVE BANK OF RICHMOND, Richmond, Virginia, and CHASE BANK OF MARYLAND, successor in interest to Chesapeake Savings and Loan Association of Annapolis, Inc.

WHEREAS, by an Assignment of Deeds of Trust recorded on April 16, 1985 as Document No. 116108 at Book 485, page 1324, and by an Assignment of Deeds of Trust recorded on June 6, 1985 as Document No. 118258 at Book 685, page 341 of the official records of Douglas County, Nevada, (hereafter called "the Original Assignments"), Chesapeake Savings and Loan Association of Annapolis, Inc. granted, assigned, and transferred to The Federal Reserve Bank of Richmond all beneficial interest under certain enumerated deeds of trust set forth in Exhibit A to those Assignments, together with the note or notes therein described or referred to, the money due and to become due with interest, and all rights accrued or to accrue under such deeds of trust; and
