17 In this action, Defendants, GURA NEVADA, INC., DOES  
18 I-V, DIRECTORS AND TRUSTEES OF GURA NEVADA, INC., having  
19 been regularly served with a Summons (Affidavit of Service  
20 attached as Exhibit 1), and having failed to appear and  
21 answer Plaintiff's Amended Complaint filed herein, the legal  
22 time for answering having expired, the Default of said  
23 Defendants and the premises having been duly entered  
24 according to law; upon application of said Plaintiff, judgment  
25 is hereby rendered against said Defendant and pursuant to the  
26 prayer of said Amended Complaint.

27 WHEREAS, for value received and accounting  
28 services performed at the specific instance and request of

1 Gura, Nevada, Inc., Gura Nevada, Inc. promised to pay  
2 on demand to Arthur Andersen & Co., the sum of \$23,100.00  
3 in lawful money of the United States of America, with  
4 interest thereon, payable in like lawful money quarterly,  
5 at the rate of 10% per annum from March 15, 1980 (Promissory  
6 Note attached hereto as Exhibit 2),

7 AND WHEREAS, as of May 1, 1986, the amount  
8 remaining to be paid was \$42,352.30 with interest accruing  
9 thereon at the rate of \$11.88 per day,

10 NOW, THEREFORE, by reason of the law and the  
11 premises aforesaid,

12 IT IS ORDERED, ADJUDGED AND DECREED:

13 1. There is due, owing and unpaid to Plaintiff,  
14 Arthur Andersen & Co., from the Defendants, for value  
15 received and accounting services performed, all as alleged  
16 and set forth in Plaintiff's Amended Complaint, the sum of  
17 \$42,352.30 together with interest thereon at the rate of  
18 ~~\$11.88~~ *Ten per cent per annum* per day from the first day of May, 1986, in lawful <sup>6 1/2</sup>  
19 money of the United States.

20 2. Plaintiff is hereby awarded judgment against
