28 amount of \$11,025.65 principal, \$2,021.32 interest accruing at

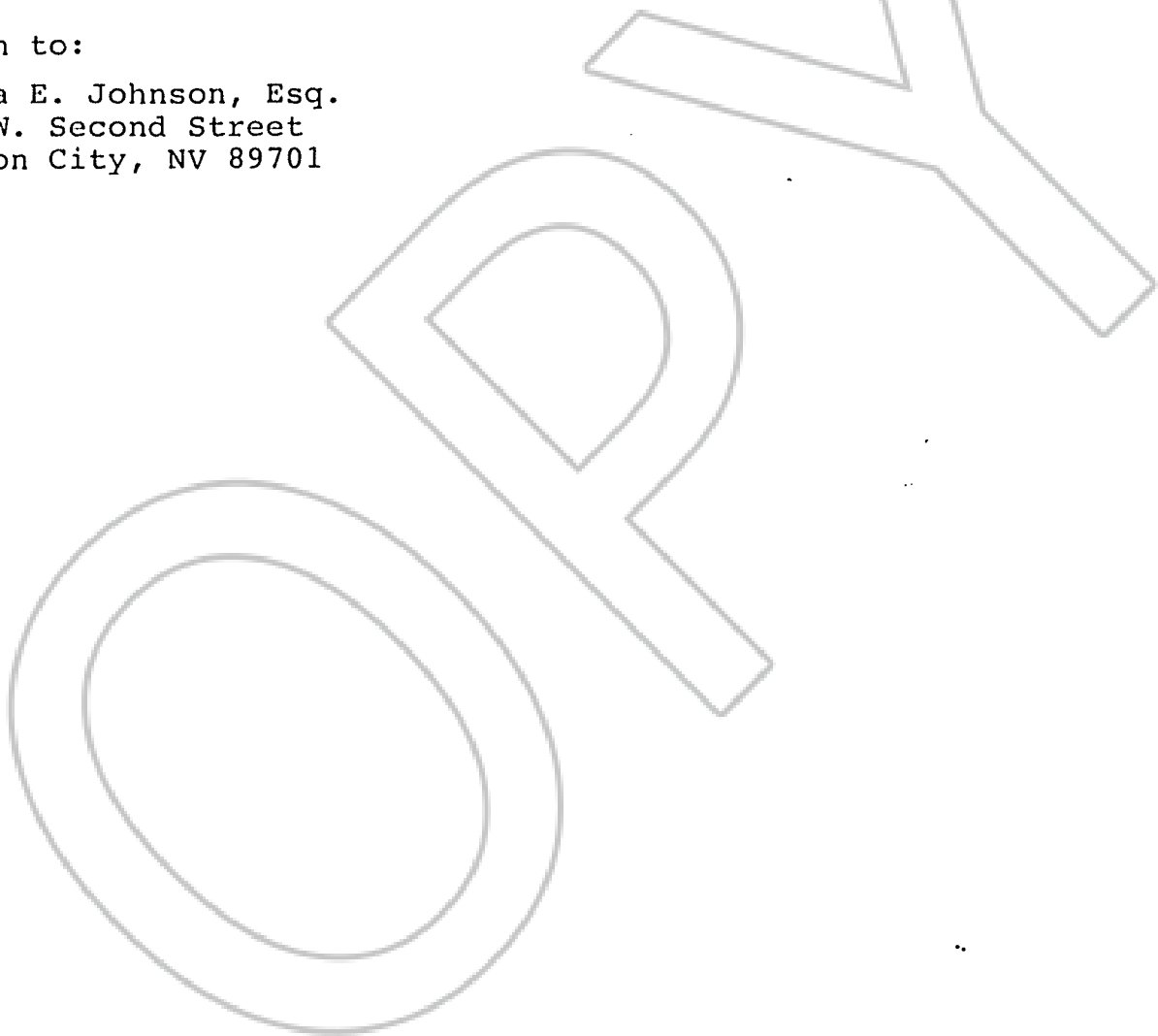
1 12% from January 1, 1985, \$1,300 in attorney's fees, and \$104
