DESCRIPTION SHEET

ALL THAT CERTAIN LOT, PIECE OR PARCEL OF LAND SITUATE IN THE COUNTY OF DOUGLAS, STATE OF NEVADA, DESCRIBED AS FOLLOWS:

Being a portion of the Southwest Quarter of Section 34, Township 14 North, Range 18, East, M.D.B. & M., and described as follows:

PARCEL NO. 1

Commencing at the Southeast corner of Lot 7 of Subdivision Survey of Lot 3, Section 34, Township 14 North, Range 18 East, as filed in Book R of Deeds at Page 163, Official Records of Douglas County Nevada; thence along the Southerly line of said Lot 7 North 89°53 00" West a distance of 100.00 feet the TRUE POINT OF BEGINNING; thence North 00°31'00" East, parallel to the East line of Lot 7, 120.00 feet to a point on the Southerly line of that certain parcel as described in Book 3 at Page 418, Official Records of Douglas County, Nevada; thence thence along said line North 89°53'00" West a distance of 50.00 feet feet to the Southeast corner of that certain parcel as described in Book 69, at Page 118, Official Records, Douglas County, Nevada; thence thence along the Southerly line of said Parcel North 89°53'00" West a distance of 150.72 feet to the Easterly right of way of Highway 50; thence Southerly along said right of way a distance of 120.3 feet, more or less, to the Southerly line of Lot 7; thence along said Southerly line South 89°53'00" East a distance of 189.00 feet, more or less to the Point of Beginning.

PARCEL NO. 2

TOGETHER WITH an undivided 1/4 interest in and to that certain well that bears South 4°43'40" West a distance of 3848.88 feet from the North quarter section corner of said Section 34, with an undivided 1/4 interest in the pump house, and equipment used in connection therewith, and the right to use an existing pipeline from said well to the hereinafter described easement with the right to install an additional pipeline paralleling the course of said existing pipeline and installed as close thereto as possible, together with the right to repair, replace and maintain the same.
