

CONTRACT FOR SERVICES OF '86 AUG 15 A6:32
INDEPENDENT CONTRACTOR

The parties to this agreement are DOUGLAS COUNTY, NEVADA, acting by and through the Juvenile Probation Department, and its Chief Juvenile Probation Officer, Scott Cook, hereinafter referred to as DOUGLAS COUNTY, NEVADA; and TIM WHITE, hereinafter referred to as CONTRACTOR.

Preamble

WHEREAS, it is deemed that the services of CONTRACTOR herein specified are both necessary and desirable and in the best interest of DOUGLAS COUNTY, NEVADA; and

WHEREAS, CONTRACTOR represents that he is duly qualified and able to render the services as hereinafter described:

1. This contract shall be effective from the 13TH day of August, 1986, to the 30th day of June, 1987, unless sooner revoked by either party as set forth in paragraph (2).

2. This contract may be revoked without cause by either party prior to the ending date set forth in paragraph (1), provided that a revocation shall not be effective until fifteen (15) days after a party has served written notice of revocation upon the other party.

3. The parties agree that the services to be performed are as follows:

CONTRACTOR will perform the duties of juvenile probation officer.

4. CONTRACTOR agrees to provide the services as set forth in paragraph (3) pursuant to the following schedule:

a) Contractor will not be compensated for any hours Contractor is not actually performing services to the County.

1 b) Any hours provided by the contractor in excess of forty per
2 week shall be payable at a rate of \$13.34 per hour. A work week shall
3 be 0001 hours, Wednesday morning, to 2400 hours, Tuesday.

4 DOUGLAS COUNTY, NEVADA, agrees to pay CONTRACTOR wages due in
5 installments of \$711.30 as follows: biweekly, commencing August 13,
6 1986.

7 5. This contract shall be construed and interpreted according to
8 the laws of the State of Nevada.

9 6. The CONTRACTOR shall neither assign, transfer nor delegate any
10 rights, obligations, or duties under this agreement without the prior
11 written consent of DOUGLAS COUNTY, NEVADA.

12 7. CONTRACTOR agrees to indemnify, save and hold DOUGLAS COUNTY,
13 NEVADA, its agents and employees harmless from any and all claims,
14 causes of action or liabilities arising from the performance of this
15 agreement by CONTRACTOR. The parties agree that the CONTRACTOR is an
16 independent contractor and is not a classified employee entitled to the
17 protection and benefits authorized by the Classified Merit Personnel
18 System of Douglas County, Nevada. Accordingly, CONTRACTOR understates
19 and acknowledges that he is not a DOUGLAS COUNTY, NEVADA, employee and
20 that there shall be no:

- 21 a. Withholding of income taxes by DOUGLAS COUNTY, NEVADA;
22 b. Accumulation of vacation, sick or holiday leave; and
23 c. Unemployment compensation provided by DOUGLAS COUNTY, NEVADA.
24 d. Participation in group insurance plans which may be available
25 to classified employees of DOUGLAS COUNTY, NEVADA;

26 The term of this agreement is eleven months commencing the 13th
27 day of August, 1986.
