

Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies (certify) that he (she, they) has (have) located the Ramona Lode Mining Claim in Section 25, Township 12N, Range 21E in the Pine Nut Mining District, in Douglas County, in the State of Nevada, on the 17th day of August, 1986.

The claim is 1500 feet long and 600 feet wide, and 750 feet is claimed in a NW direction and 750 feet in a 50E direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the NW to the 50E.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by black indel. blk marker

- Corner No. 6 is a 3" x 4' white plastic pipe

The monumentation and marking of the corners was completed by the 16th day of October, 1986.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Douglas County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
