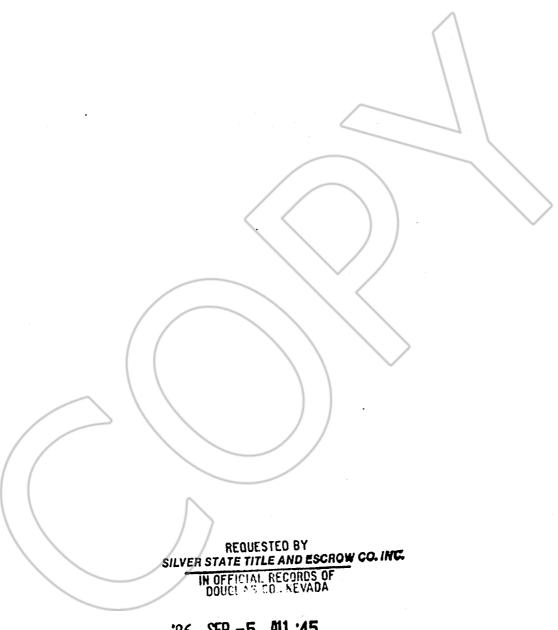

## ASSUMPTION AGREEMENT AND MODIFICATION OF DEED OF TRUST
