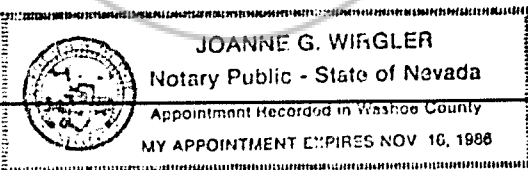


EXHIBIT "B"
