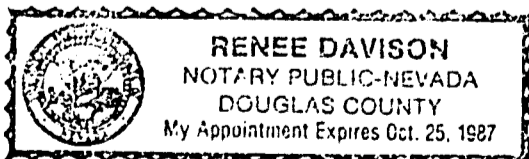

**LEGAL DESCRIPTION**
