with interest, and all rights accrued or to accrue under said Deed of Trust with Assignment of Rents including the right to have reconveyed, in whole or in part, the real property described therein.

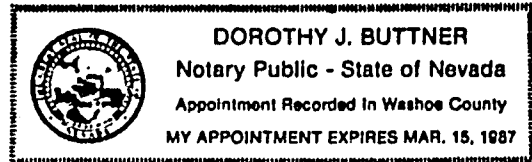
