RESOLUTION OF ABANDONMENT

WHEREAS, the State of Nevada, Department of Transportation, presently holds an easement interest for portions of that certain right-of-way for State Route 206 (Foothill Road) and SAR-758 (Genoa Lane) from the east section line of Section 9, T. 13 N., R. 19 E., M.D.M. along State Route 206 and SAR-758 to Highway Engineer's Station Equation "B" 180+00.00 P.O.T. equals "A" 180+00.00 P.O.T.; and

WHEREAS, the said right-of-way is delineated by shading and identified as parcels numbered 1 through 3, inclusive, on Exhibits "A" and "B", attached hereto and made a part hereof; and

WHEREAS, the Department of Transportation, pursuant to the provisions contained in NRS 408.523, may vacate or abandon by resolution, any portion of a state highway which is in excess of its needs; and

WHEREAS, a portion of said right-of-way is of no further contemplated use by the State of Nevada, Department of Transportation, due to those certain portions of State Route 206 and SAR-758 being in excess of the needs of the department.

NOW THEREFORE be it resolved by the Board of Directors of the Department of Transportation of the State of Nevada, that the following described right-of-way and incidents thereto, being all that land delineated by shading and identified as parcels numbered 1 through 3, inclusive, on Exhibits "A" and "B", be and hereby is abandoned. Said right-of-way is more particularly described as follows:

Lying and being in the County of Douglas, State of Nevada, and being portions of the E 1/2 of Section 9, and the W 1/2 of Section 10, all in T. 13 N., R. 19 E., M.D.M.; and being further described as follows, to wit:

Parcel 1

Being all that land lying outside and westerly of the right-of-way line 30.00 feet left of, westerly and parallel with the centerline of SR-206 (Foothill Road) extending from a point 30.00 feet left of Highway Engineer's Station "B" 290+11.88 P.C. northerly a distance of approximately 823 feet to an intersection of said 30.00 foot line with the southerly right-of-way line of Nixon Street.
