

SHORT FORM DEED OF TRUST AND ASSIGNMENT OF RENTS

This Deed of Trust, made this 28th day of November, between

JOHN S. ADAMICK, a married man

whose address is Post Office Box 6366, Burbank, CA 91510, herein called TRUSTOR, (number and street) (city) (zone) (state)

Ticor Title Insurance Company, a California corporation, herein called TRUSTEE, and GORDON R. HOWARD, a married man

Witnesseth: That Trustor IRREVOCABLY GRANTS, TRANSFERS AND ASSIGNS TO TRUSTEE IN TRUST, WITH POWER OF SALE, that property in Douglas County, Nevada, described as:

Lots 1 through 12 inclusive, in Block G, as shown on the map of the West Addition to the Town of Minden, filed in the office of the County Recorder of Douglas County, Nevada.

In the event of sale or transfer of title to the real property set forth herein, the entire amount of the Note secured hereby shall become immediately due and payable at the option of the beneficiary.

TOGETHER WITH the rents, issues and profits thereof, reserving the right to collect and use the same except during continuance of some default hereunder and during continuance of such default authorizing Beneficiary to collect and enforce the same by any lawful means in the name of any party hereto.

Payment of such additional sums as may hereafter be advanced for the account of Trustor or Assigns by Beneficiary with interest thereon.

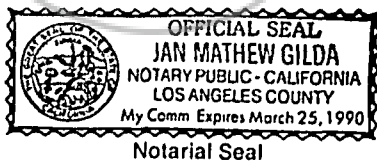
