GRANT OF DRAINAGE EASEMENT

The perpetuate right to enter upon the real estate hereinafter described, at any time that it may deem fit, and to construct, maintain and repair drainage facilities for the purpose of draining and conveying water over, across, through and under the lands hereinafter described, together with the right to excavate and refill ditches and trenches for the location of said drainage facilities, and the further right to remove trees, bushes, undergrowth and other obstructions interfering with the location, construction and maintenance of said drainage facilities.

The easement right of way hereby granted is situate on those portions of Lot 3, Block "A" as said lot is shown on the Official Plat of Sierra Shadows, recorded June 30, 1980, Document No. 45811, more particularly described as follows:

- 1. Beginning at the Northwest corner of said Lot 3; thence South 71°18'10" East 20.00 feet; thence South 19°41'50" West 119.00 feet; thence North 70°18'10" West 20.00 feet; thence North 19°41'50" East 119.00 feet to the POINT OF BEGINNING.

Beginning at the Northeast corner of said Lot 3; thence South 19°41'50" West 119.00 feet along the Easterly line of said Lot 3 to the Southeast corner of Lot 3; thence North 70°18'10" West 20.00 feet; thence North 19°41°50" East 119.00 feet to a point on the North line of Lot 3; thence South 71°18'10" East 20.00 feet to the POINT OF BEGINNING.

These easements are given on the agreement by the Grantee, SIERRA SHADOWS ASSOCIATION, that in the event of any construction, maintenance, repair or other disturbance by it of the easement area, that it will restore the easement area as nearly as possible to its former condition, including paving if necessary.

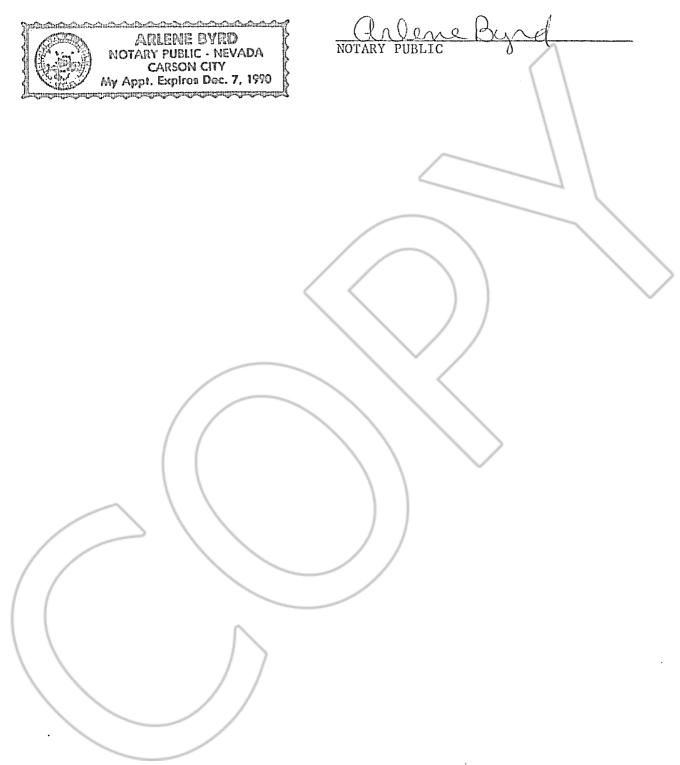

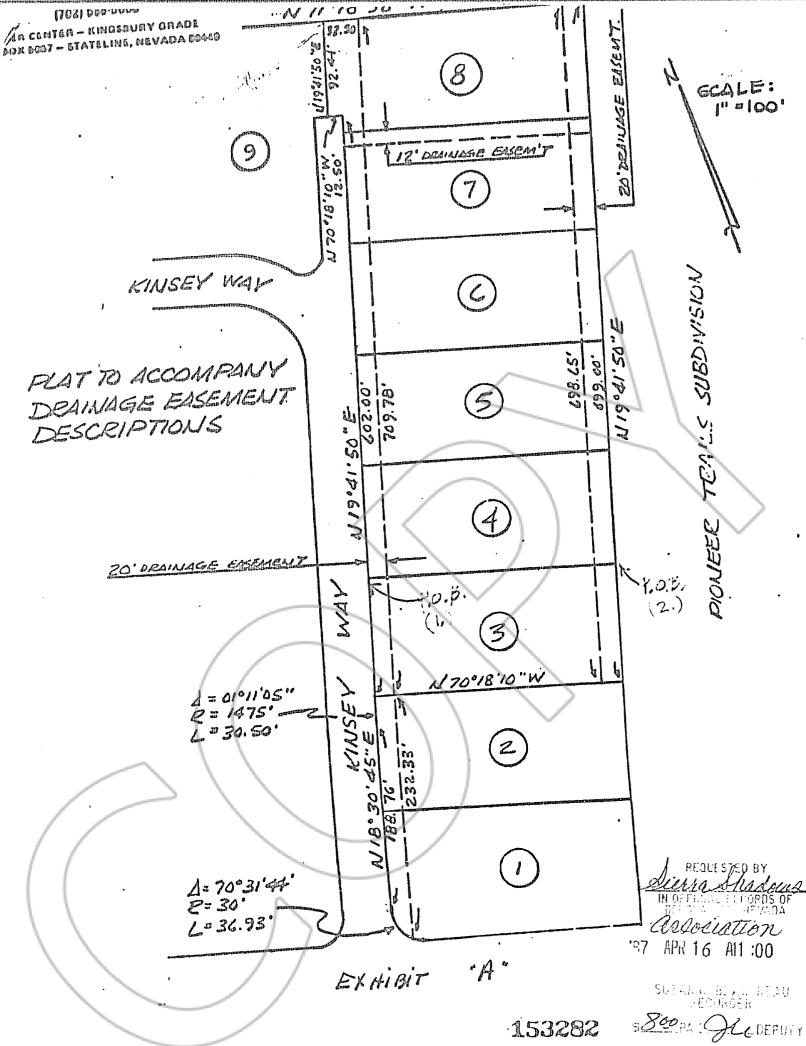
