GRANT, BARGAIN AND SALE DEED  
IN LIEU OF FORECLOSURE

THIS GRANT, BARGAIN AND SALE DEED IN LIEU OF FORECLOSURE is made and executed this 6<sup>th</sup> day of February, 1987, by JEROME R. HALLBERG, a single man, ("GRANTOR") and TAHOE SUMMIT CORPORATION, a Nevada corporation ("GRANTEE"),

W I T N E S S E T H:

That GRANTOR, for good and valuable consideration, receipt of which is hereby acknowledged, does by these presents grant, bargain and sell unto GRANTEE, its successors and assigns forever, all that certain real property situate in the County of Douglas, State of Nevada, and more particularly described in Exhibit "A" attached hereto, said description by this reference being incorporated herein as if set forth in its entirety,

TOGETHER WITH all and singular the tenements, hereditaments and appurtenances thereunto belonging or appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof,

TO HAVE AND TO HOLD all and singular the said premises, together with the appurtenances, unto GRANTEE and to its successors and assigns forever.

This deed is a conveyance in lieu of foreclosure and such conveyance by the GRANTOR shall be considered, and is, full satisfaction of all obligations secured by that certain Deed of Trust executed by GRANTOR to SILVER STATE TITLE COMPANY, as Trustee for TAHOE SUMMIT VILLAGE TIME SHARE DEVELOPERS, a joint venture, as Beneficiary, and recorded July 20, 1984, in the Office of the County Recorder of Douglas County, Nevada, in Book 784 of the official records at page 1940 as Document No. 103910, and shall be considered, and is, a release of GRANTEE of any

A Time Share Estate comprised of:

Parcel One:

An undivided 1/51st interest in and to that certain condominium described as follows:

(a) An undivided 1/9th interest, as tenants-in-common, in and to Lot 28 of Tahoe Village Unit No. 2, Third amended Map, recorded February 26, 1981, as Document No. 53845, Official Records of Douglas County, State of Nevada, except therefrom units 1 to 9.

(b) Unit No. A as shown and defined on said last mentioned map.

Parcel Two:
