reference as if the same were fully set forth herein.

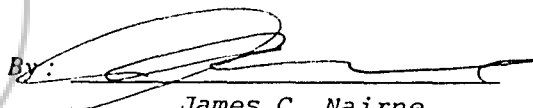

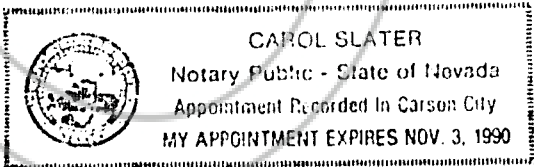
