ORDER FOR APPOINTMENT
OF GUARDIANSHIP AND
ISSUANCE OF LETTERS
OF GUARDIANSHIP

11 The Court having reviewed the allegations of the Petition
12 for Appointment of Guardian, and after the hearing on the Petition
13 for Appointment of Guardian was held, and no person entitled
14 to object to the Petition has done so, the Court finds that
15 said allegations are true:

16 IT IS HEREBY ORDERED THAT:

- 17 1. Charles R. Grant, the brother of the proposed adult
18 ward, Donald Lee Grant, is appointed the general guardian of
19 the person and the estate of Donald Lee Grant in Nevada.
- 20 2. The Court finds that Donald Lee Grant is a resident of
21 the County of Douglas, State of Nevada, residing at 2621 Fuller
22 Avenue, Johnson Lane, Minden, Nevada 89423.
- 23 3. The official bond of Charles R. Grant as guardian of
24 the ward, and of his person and estate, shall be set in the
25 amount of \$ 0 and filed with the Court Clerk.
- 26 4. The Court, pursuant to NRS 159.047 finds that notice
27 of the citation has been served to the relatives within the

1 second degree of the proposed ward. Further, a copy of the
2 citation has been served upon Washoe Medical Center of 77 Pringle
3 Way, Reno, Nevada 89502, the institution having the physical
4 care, custody and control of the proposed ward.

5 5. The Court finds that as alleged in the Petition, the
6 proposed ward faces a substantial and immediate risk of financial
7 loss if a guardian is not appointed on his behalf for his person
8 and for his estate.

9 6. The name of the guardian appointed is Charles R. Grant
10 with mailing address of P.O. Box 20508, San Diego, California
11 92120.

12 7. The name of the attorney for the appointed guardian is
13 Michael Smiley Rowe, Esq., located at 1638 Esmeralda Street,
14 Minden, Nevada 89423 with mailing address of P.O. Box 2080,
15 Minden, Nevada 89423, and telephone number of (702) 782-8141.


16 8. That the guardian, in addition to the statutorily
17 conferred powers, is specifically empowered to marshal all
18 the assets of the proposed ward, investigate all accounts,
19 safe deposit boxes and insurance policies, and to otherwise
20 compile and review the documents relating thereto.

21 9. The Court waives appointment of an investigator pursuant
22 to NRS 159.046.
