

9 FOR A VALUABLE CONSIDERATION, receipt of which is hereby

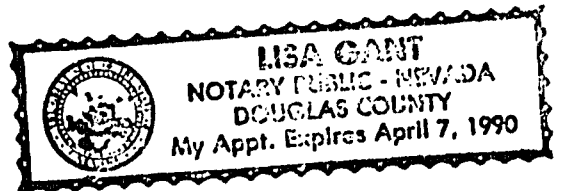

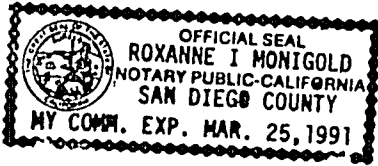
