
EXHIBIT "A"

LEGAL DESCRIPTION

All that portion of the East Half of the Southwest Quarter of Section 3, Township 14 North, Range 18 East, M.D.B.& M., more particularly described as follows:

COMMENCING at the Northwest corner of the Northeast Quarter of the Southwest Quarter of said Section 3; thence North 89°34'00" East, 20.00 feet along the North line of the Southwest Quarter of said Section 3 to the TRUE POINT OF BEGINNING; thence continuing along said North line, North 89°34'00" East 202.77 feet; thence leaving said North line, South 01°15'53" West, 1426.72 feet; thence 01°15'00" West 353.55 feet to a point on the meander line of Lake Tahoe; thence South 01°15'00" West 23.80 feet, more or less to a point on the low water line of Lake Tahoe; thence along the low water line South 87°45'00" West 103.33 feet; thence South 77°00'00" West 43.00 feet; thence North 00°37'10" West 52.00 feet, more or less, to a point on the meander line and a point on the East line of Harris Heights, Doc. #6000; thence along said East line North 00°37'10" West 303.55 feet to a point on the centerline of a roadway easement; thence North 00°33'09" West 1460.36 feet to the TRUE POINT OF BEGINNING.
