JUDGMENT


THIS MATTER having come before the Court on the Complaint of Plaintiff, Answer of Defendants, and Plaintiff's Motion for Summary Judgment, Defendants having received Notice of Hearing on said Motion for Summary Judgment but having failed to appear, and the Court having considered Plaintiff's uncontroverted Affidavit in Support of Motion for Summary Judgment and having considered the record and being fully advised in the premises, FINDS:

1. That this Court has jurisdiction over the parties hereto and the subject matter hereof.


2. That the allegations contained in Plaintiff's Complaint are true and correct and Plaintiff is entitled to judgment against Defendants in the amount claimed, except that the statutory interest rate of 15% per annum should be applied rather than the 18% per annum claimed by Plaintiff, and therefore Plaintiff should have and recover from Defendants, jointly and severally, the sum of eighteen thousand thirty-two dollars seven cents (\$18,032.07), including interest at the rate of 15% per annum to September 22, 1987.

3. That Plaintiff should also recover its costs herein in the amount of sixty dollars (\$60.00) and reasonable attorneys' fees in the amount of two thousand two hundred dollars (\$2,200.00).

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED that Plaintiff is hereby granted judgment against the Defendants, Maurice E. Barbara and Candace Barbara, jointly and severally; in the amount of eighteen thousand thirty-two dollars seven cents (\$18,032.07), together with costs in the amount of sixty dollars (\$60.00) and reasonable attorneys' fees in the amount of two thousand two hundred dollars (\$2,200.00). This Judgment shall bear interest at the statutory rate of 15% per annum from date of entry hereof until paid in full.






