## ASSIGNMENT OF CONTRACTS, NOTES RECEIVABLE

## AND INTERVAL DEEDS OF TRUST

ASSIGNMENT ("this Assignment"), made and executed this 97H day of OCTOBER, 1987, by HARICH TAHOE DEVELOPMENTS, a Nevada general partnership ("the Debtor"), in favor of SECURITY CAPITAL CREDIT CORPORATION, a Delaware corporation ("the Lender").

## WITNESSETH:

WHEREAS, the Debtor and the Lender have entered into a General Loan and Security Agreement dated December 19, 1986 (as amended from time to time, the "Agreement"), pursuant to which the Lender has agreed to lend, upon the terms and conditions set forth in the Agreement, up to Ten Million Dollars (\$10,000,000.00) ("the Loan") to the Debtor to be evidenced by a Secured Promissory Note ("the Note"), and secured by a Lien granted by the Debtor to the Lender on certain Contracts, Notes Receivable and Interval Deeds of Trust and other Collateral of the Debtor.

NOW, THEREFORE, to secure the payment and performance of the obligations of the Debtor to the Lender under the Agreement and the Note and in consideration of the extension of the Loan to the Debtor, the Debtor hereby conveys, assigns, transfers and sets over unto the Lender all of its rights, title and interest in and to the Contracts, Notes Receivable and Interval Deeds connected therewith assigned to the Lender pursuant to the terms of the Agreement, together with all proceeds derived therefrom and other Collateral delivered in substitution or replacement thereof.

The terms defined in the Agreement, unless otherwise defined herein, are used herein with the defined meanings ascribed to them in the Agreement.

The Debtor hereby warrants and represents to the Lender that the Contracts, Notes Receivable and Interval Deeds of Trust assigned hereby are held by the Debtor free and clear of all prior Liens, security interests, charges and encumbrances whatsoever and covenants and agrees with the Lender to maintain the same in good standing at all times in accordance with the terms thereof and not to take any action with respect to said Contracts, Notes Receivable and Interval Deeds of Trust which may be prejudicial to the right of the Lender hereunder.

This Assignment is executed only as security for the Obligations of the Debtor under the Agreement and the Note. The execution and delivery of this Assignment shall not subject the Lender to, or transfer or pass to the Lender, the Contracts, Notes Receivable or Interval Deeds of Trust, it being understood and agreed that notwithstanding this Assignment or any subsequent assignment, all of the obligations of the Debtor to each and every other party under each and every one of the Contracts, Notes Receivable and Interval Deeds of Trust shall be and remain enforceable by such other party, its successors and assigns, only against the Debtor or Persons other than the Lender and its

respective successors and assigns, and that the Lender has not assumed any of the obligations or duties of the Debtor under or with respect to any of the Contracts, Notes Receivable or Interval Deeds of Trust.

The Debtor hereby agrees and acknowledges that neither the acceptance of this Assignment by the Lender nor the exercise of, or failure to exercise, any right, power or remedy in this instrument conferred upon the Lender shall be deemed or construed to obligate the Lender, or its successors or assigns, to pay any sum of money, take any action or incur any liability in connection with any of the Contracts, Notes Receivable or Interval Deeds of Trust hereby assigned to the Lender. It is further agreed and understood by the Debtor that neither the Lender nor its successors or assigns shall be liable in any way for any costs, expenses or liabilities connected with, or any charges or liabilities resulting from, any of the Contracts, Notes Receivable or Interval Deeds of Trust.

This Assignment shall be binding upon the Debtor and its successors and assigns, and shall inure to the benefit of the Lender and its successors and assigns. This Assignment shall be governed by, and shall be construed under, the laws of the State of Nevada.
