25 day of October, 1987, to which reference is hereby made.

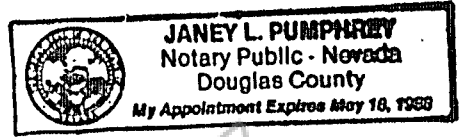
