notice of this hearing as required by law; that no person has appeared to oppose the First and Final Account, Report and Petition; and the Court being fully advised in the premises, further finds:

- 1. That all allegations of the First and Final Account, Report of Administratrix, Petition for Allowance of Attorney's Fees, for Distribution and Discharge are true.
- 2. That Vivian Tervele Clapham died on December 7, 1982, resident and domicilary of the County of Douglas, State of Nevada.
- 3.
