complaint on September 15, 1987, but the Clerk of this Court having entered a default in accordance with Rule 55(a) of the Nevada Rules of Civil Procedure on September 9, 1987, and plaintiffs having filed an affidavit in support of default, an application for entry of default judgment, and notice of entry of default judgment on September, 1987, this Court finds all the allegation in the complaint to be true, and the plaintiff thereby is entitled to the relief prayed for in the complaint;

THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED as follows:

- 1. Plaintiff shall have and recover judgment in the amount of \$1,986.93, which sum represents the remaining balance due plaintiff for public assistance provided during the periods June, 1978, through January, 1981, and May, 1981, through August, 1981, for the support of defendant's children RICHARD ARDELL BULTENA, born November 13, 1961, now emancipated, and PAMELA BECKY BULTENA, born August 10, 1963, now emancipated.
- 2. Defendant shall pay \$200.00 per month as reimbursement for the \$1,986.93 balance owing plaintiff, with the initial payment due on November 1, 1987, and subsequent payments due on the first day of each month thereafter until \$1,986.93 has been paid in full or further order of this court.
- 3. That said monthly payments shall be made by defendant in either in the form of a cashier's check, certified check, or money order or in cash. If the payment is in the form

of cash, it must be delivered to the Douglas County Clerk at her office in Minden, Nevada. If the payment is in the form of a cashier's check, certified check, or money order, it must be made payable to the DOUGLAS COUNTY CLERK and be either mailed to the Douglas County Clerk at Post Office Box 218, Minden, Nevada 89423, or delivered to said County Clerk at her office in Minden, Nevada. The Douglas County Clerk shall transmit said payments to OFFICE OF SUPPORT ENFORCEMENT, P.O. Box 4269, Vancouver, WA 98662.

- 4. Defendant is hereby advised that if his public assistance reimbursement payments become 30 days delinquent a wage withholding will be issued in accordance with NRS chapter 31A.
- 5. Enforcement of this order is stayed for 30 days to allow Peter Knight, Esquire, to submit evidence warranting modification of said judgment in accordance with NRCP 60(d).
