Balkenbush, Deputy District Attorney, Douglas County, Nevada, and neither defendant nor his legal counsel, Peter Knight, Esquire, appearing in Court. Mr. Knight having previously communicated to plaintiffs' legal counsel that he would be unavailable for a Court appearance on today's date due to a Court trial in Goldfield, Nevada, on today's date.

Defendant ARDELL ANDREW BULTENA, having been duly served with a Summons and Complaint in the above-entitled matter on the 15th day of July, 1987, and having filed an answer to said

1 complaint on September 15, 1987, but the Clerk of this Court
2 having entered a default in accordance with Rule 55(a) of the
3 Nevada Rules of Civil Procedure on September 9, 1987, and
4 plaintiffs having filed an affidavit in support of default, an
5 application for entry of default judgment, and notice of entry of
6 default judgment on September, 1987, this Court finds all the
7 allegation in the complaint to be true, and the plaintiff thereby
8 is entitled to the relief prayed for in the complaint;
9

10 THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED as
11 follows:

12 1. Plaintiff shall have and recover judgment in the
13 amount of \$1,986.93, which sum represents the remaining balance
14 due plaintiff for public assistance provided during the periods
15 June, 1978, through January, 1981, and May, 1981, through August,
16 1981, for the support of defendant's children RICHARD ARDELL
17 BULTENA, born November 13, 1961, now emancipated, and PAMELA
18 BECKY BULTENA, born August 10, 1963, now emancipated.
19

20 2. Defendant shall pay \$200.00 per month as
21 reimbursement for the \$1,986.93 balance owing plaintiff, with the
22 initial payment due on November 1, 1987, and subsequent payments
23 due on the first day of each month thereafter until \$1,986.93 has
24 been paid in full or further order of this court.


25 3. That said monthly payments shall be made by
26 defendant in either in the form of a cashier's check, certified
27 check, or money order or in cash. If the payment is in the form
28

1 of cash, it must be delivered to the Douglas County Clerk at her
2 office in Minden, Nevada. If the payment is in the form of a
3 cashier's check, certified check, or money order, it must be made
4 payable to the DOUGLAS COUNTY CLERK and be either mailed to the
5 Douglas County Clerk at Post Office Box 218, Minden, Nevada
6 89423, or delivered to said County Clerk at her office in Minden,
7 Nevada. The Douglas County Clerk shall transmit said payments to
8 OFFICE OF SUPPORT ENFORCEMENT, P.O. Box 4269, Vancouver, WA
9 98662.

11 4. Defendant is hereby advised that if his public
12 assistance reimbursement payments become 30 days delinquent a
13 wage withholding will be issued in accordance with NRS chapter
14 31A.

15 5. Enforcement of this order is stayed for 30 days to
16 allow Peter Knight, Esquire, to submit evidence warranting
17 modification of said judgment in accordance with NRCP 60(d).
