16 A stipulation by and between the parties having been
17 filed with this Court in relation to the above-entitled matter,
18 the court having reviewed said stipulation and all other
19 pleadings and documents on file with the clerk of this Court, the
20 parties having agreed to the entry of this order and judgment by
21 their stipulation, and good cause appearing;

22 This Court finds, concludes, and orders as follows:

23 FINDINGS OF FACT

24
25 1. Defendant is the father of JONATHAN W. TURNER, JR.,
26 born March 30, 1977.

27 2. On or about January 20, 1983, the Family Court of
28 Hamilton County, New York, entered an order requiring the

1 defendant to pay the sum of \$35.00 per week for the support of
2 his minor son JONATHAN W. TURNER, JR., said payments to be made
3 through the Hamilton County Support Collection Unit, Lake
4 Pleasant, New York. This order also required the defendant to
5 purchase a \$50.00 savings bond each month for his minor son,
6 JONATHAN W. TURNER, JR., said bonds to be turned over to his
7 minor son upon his attainment of the age of eighteen years. This
8 support order was terminated by later order entered by the Family
9 Court of Hamilton County, New York, in or around January, 1984.

10
11 3. The Hamilton County Department of Social Services,
12 Lake Pleasant, New York, paid out public assistance monies as and
13 for the support of defendant's minor son, JONATHAN W. TURNER,
14 JR., during the period January 16, 1986, through August 11, 1987,
15 in the amount of \$2,719.50.

16 4. Defendant agrees to pay \$208.00 per month to the
17 Hamilton County Department of Social Services. Defendant further
18 agrees that each month \$158.00 of the \$208.00 monthly amount be
19 given to Mary Turner for the current support of defendant's minor
20 son, JONATHAN W. TURNER, JR. Defendant also agrees that the
21 remaining \$50.00 of each \$208.00 monthly payment be taken by the
22 Hamilton County Department of Social Services and applied as
23 reimbursement for the \$2,719.50 which it paid out as public
24 assistance.

26 5. Defendant desires that this court enter an order
27 requiring that the \$208.00 monthly payment for support be

1 withheld from his wages and commissions. Defendant's request is
2 made freely and voluntarily.

3 6. Every finding of fact hereinabove which is held
4 upon review to be a conclusion of law is hereby adopted as such.

5 CONCLUSIONS OF LAW

6 1. This Court has jurisdiction of the subject matter
7 and the defendant.

8 2. Under Nevada law, defendant's payments for support
9 may be withheld from his wages and commissions by his voluntary
10 request.

11 3. Defendant owes a duty of support to his minor son
12 JONATHAN W. TURNER, JR.

13 4. Defendant must reimburse Hamilton County Department
14 of Social Services, Lake Pleasant, New York, for the \$2,719.50
15 paid out as public assistance.

16 5. Every conclusion of law here and above which upon
17 review is held to be a finding of fact is hereby adopted as such.

18 ORDER AND JUDGMENT

19 1. Plaintiff shall have and recover judgment in the
20 amount of \$2,719.50, which sum represents public assistance
21 provided for the support of defendant's minor child, JONATHAN W.
22 TURNER, JR., during the period January 16, 1986, through August
23 11, 1987.

24 2. Defendant shall pay \$50.00 per month as
25 reimbursement for the \$2,719.50 paid out as public assistance by
26 the Hamilton County Department of Social Services, Lake Pleasant,
27 New York.
